## **A) FINANCIAL SANCTIONS AND COURT FEES TO BE COVERED BY THE UNSUCCESSFUL PARTY IN PROCEEDINGS HELD BEFORE THE NATIONAL ANTI-DOPING TRIBUNAL (NADT)**

In addition to imposing the individual sanctions as under article 11 of the ADSC, the NADT may decree that the unsuccessful party should pay financial sanctions as well as covering court fees as under article 16 of the ADSC, with the relevant amount being settled as outlined hereinafter.

### **Financial Sanctions**

Financial sanctions shall range from a minimum of € 100.00 to a maximum of € 50,000.00. For the purposes of determining the amount of the sanction to be inflicted, in reaching its decision the NADT must take account of the severity of the violation committed, the established degree of responsibility, the likelihood of repetition of breaches as well as the conduct shown during the proceedings.

### **Operating Costs and Court Fees**

When determining court fees and expenses, the NADT shall refer to:

- the operating costs of the Judging Panel to the extent of the attendance fees accounted for in the disciplinary proceedings as a whole, plus VAT and statutory fees;
- the expenses pertaining to professional tasks performed by any experts appointed by the court and/or parties who took part in the proceedings;
- such additional court fees as the Judging Panel may incur in dealing with the dispute<sup>1</sup>.

### **Payment Deadlines and Late or Non-compliance**

The ruling whereby the unsuccessful party is ordered to pay financial sanctions shall have immediate effect. The relevant payment must be made by such party within ten days after the ruling has been read out at the hearing or after notice thereof served by the Judging Panel. Upon expiry of such deadline, action shall be taken to enforce payment before the relevant Authorities, with any additional legal expenses, fees and interests being charged.

Failure to pay the amounts as decreed by the Judging Panel and the amounts deemed as payable to NADO Italia by the Court of Arbitration for Sport in Lausanne (CAS) and/or Swiss Federal Tribunal shall result in enforced collection of such amounts before the relevant Judicial Authorities.

### **Payment by Instalments of the Amounts Determined by the NADT, CAS and/or Swiss Federal Tribunal deemed as payable to NADO Italia**

Upon request of the unsuccessful party, to be sent to NADO Italia, payment by instalments may be granted.

It is understood, however, that any deferred payment arrangement shall not exceed the expiry of the Period of Ineligibility and/or ban.
